## PAV Ad Hoc Finance Committee Recommendations for a Vicariate Finance Committee

### Finance Committee Mission Statement

The Pontiac Area Vicariate Finance Committee focuses on the effective management and use of the Vicariate financial resources.

### Finance Committee Guidelines

1. Review quarterly financial statements and provide a status report to the VPC and the PMA.
2. Provide input, review, and make a recommendation on the PAV Operating Budget.
3. Insure the objectives set by the VPC are receiving the proper funding.
4. Review the Annual Report for submission to the Archdiocese.
5. Provide a yearly report on the Vicariate fiscal status to the VPC.
6. Provide an oversight function for the PAV Vision 2000 Campaign.
7. Conduct a yearly review of the internal controls over Vicariate funds.
8. Conduct quarterly reviews of the PAV bank reconciliations.

### Membership

1. Three to five people plus the PAV Business Manager.
2. Members should be from the VPC and/or parish finance committees.
3. The membership terms should be 3 year, staggered terms.
4. Meetings should be conducted quarterly before VPC meetings.
